I am seeking approval of the FY26 PPEL Resolution allowed under section 281.98.64 of the Code of Iowa. The Physical Plant and Equipment Levy (PPEL) equals a property tax levy of .33 cents / \$1,000 for the FY26 Budget Year. The levy is used to purchase or lease new or used student transportation vehicles (i.e yellow school bus or suburban) for the student transportation fleet as older vehicles are retired or other planned fleet changes are executed. All 325 public school school districts in the state of Iowa levy this property tax.
